

RULES OF PROCEDURE

CAMPING DE MON VILLAGE Area

Considering the general local authorities code.

Considering the development of the area CAMPING-CAR PARK in the municipality of **TONNAY BOUTONNE**.

Considering that it is the Mayor's responsibility to take all useful measures in order to prevent accidents and to safeguard the good order, safety, health and tranquility of everyone.

Considering the customer management, the collection of stays, the booking management and the promotion of the area is dealt by the company CAMPING-CAR PARK.

GENERAL

Article 1

The stationing in the area of the CAMPING-CAR PARK of **TONNAY BOUTONNE** is allowed all year round for Motorhomes and self-contained vans.

Cars and vans that are not self-contained and are not approved by the Regional Directorate for Industry, Research and the Environment (D.R.I.R.E) as habitable leisure vehicles, are not authorized on the area (Ref : decree of June 7th 2002 relating to the presentation of the risks of fire, explosion and asphyxiation in habitable leisure vehicles). Any installation in meeting, without preliminary authorization could be sanctioned by the article 322-4-1 of the penal code (seizure and confiscation).

Cars and vans that are not self-contained and are not approved by the Regional Directorate for Industry, Research and the Environment (D.R.I.R.E) as habitable leisure vehicles, are not authorized on the area (Ref : decree of June 7th 2002 relating to the presentation of the risks of fire, explosion and asphyxiation in habitable leisure vehicles). Any installation in meeting, without preliminary authorization could be sanctioned by the article 322-4-1 of the penal code (seizure and confiscation).

Article 2

The CAMPING-CAR PARK area is composed of **16** pitches as well as a self-service terminal with fresh water supply and a grey and black water dump.

Article 3

Rates as well as the tourist taxes are validated by CAMPING CAR PARK or the collectivity.

Two rates are applicable: a stay up to 5h with all amenities included (water, electricity, draining of grey and black water). a stay between 5h and 24h (a 24h rate will be automatically applied beyond a 5h stay).

RULES OF USE

Article 4

A personal PASS'ETAPES card is mandatory in order to access the area. The card has to be assigned to the main driver and only one PASS'ETAPES card per vehicle is accepted.

The PASS'ETAPES card is valid for life and will be delivered by the payment terminal located at the entrance of the area after its purchase. The same PASS'ETAPES card will grant you access to all CAMPING-CAR PARK and CAMPING DE MON VILLAGE destinations.

In order to obtain a personal PASS'ETAPES card, The user will have to create a personal account providing your name, surname, telephone number (to be reached in case of emergencies) and a valid email address. This account will allow the user to access his receipts and invoices.

Various methods of payment are at the user's disposal: directly at the payment terminal, on our website/app, via telephone, cash mandat, per mail (checks and "chèques vacances").

All stays of more than 3 days will have to be paid in advance. Customers will have to scan their PASS'ETAPES card at each entry and exit of the area, even if the gate is open. In case of malfunction, it is imperative to contact CAMPING-CAR PARK's customer service located in Pornic (+33 (0)1.83.64.69.21 open 7 days a week).

Article 5

Pets are allowed. They must be kept on a leash and under surveillance at all times. Their droppings must be picked up by their owners and be discarded

accordingly. It is the responsibility of the pet's owner to ensure everyone's peace and quiet.

Article 6

Electric barbecues are not permitted.

Open fire barbecues (wood, coal, etc...) are forbidden. In case of fire, notify emergency services immediately (112 or 18).

Article 7

Gatherings in the area are forbidden between 10pm and 9am. Customers must be respectful of one another and apply the code of good conduct in regards to the neighborhood (noise and sanitation).

RESPONSIBILITY

Article 8

Each customer is responsible for the cleanliness of their pitch. Waste of any kind must be deposited in the garbage containers. The disposal of waste water is forbidden in the area, regular inspections will be carried out.

Article 9

Customers are required to respect the rules of good conduct: occupying a single space/pitch and making use of a single electrical outlet.

Article 10

Maneuvering and stationing within the area are at the risk of the vehicle's drivers who retain custody and responsibility as on a public road.

The resulting stationing and maneuvering constitutes a simple authorization and will not constitute a contract of Guarding or security depot.

The city council or CAMPING-CAR PARK shall not be held liable.

All customers stationing on the area are responsible for any damages they may cause or which is caused by any person for whom they are responsible, this includes animals or belongings in their custody.

As a result, it will be required from the customer to fully compensate for the corresponding damages.

Consequently, each customer must take care of the equipment and facilities and remain liable for any damage caused.

Article 11

Each customer must ensure to have their account sufficiently provisioned in order to cover the fee of their stay. Each customer must imperatively scan their access card while entering or exiting the area. Any fraud will be sanctioned with a fine of **300€**, voted by the local council.

Article 12

>The city council of **TONNAY BOUTONNE** of the company of CAMPING-CAR PARK, may temporarily close the area for maintenance and/or upkeep as well as for reasons of force majeure, safety or general interest

Article 13 :

Inspections may be carried out by a representative of CAMPING-CAR PARK, the city council, the gendarmerie or the police. The latter may also draw up an official report in the event of fraud. Any infringement (water theft, electricity theft, trespassing without the possession of a PASS'ETAPES card, etc.) to the present rules and regulations will be recorded and prosecuted in accordance with the laws and regulations in force. Theft is punishable by 3 years imprisonment and a fine of 45 000€ (Article 311-3 of the penal code)
