INTERNAL REGULATIONS

Camping de Mon Village - Castelnaudary - Canal du Midi

In view of the General Code of Local Authorities,

Considering the development of the CAMPING DE MON VILLAGE area in the town of Castelnaudary,

Considering that it is the responsibility of the Mayor to take all necessary measures to prevent accidents and ensure public order, safety, hygiene, and the tranquility of all,

Considering that the management of clientsincluding payment processing, booking management, and promotion is handled by the company CAMPING-CAR PARK.

GENERAL INFORMATION

Article 1

Parking in the CAMPING DE MON VILLAGE area is authorized as follows: Tents, caravans, trailers, and any towed vehicles are allowed only during the period when sanitary facilities are open. Outside of this period, no installation will be accepted. Self-contained motorhomes and vans are allowed all year round.

Converted cars and trucks that are not self-contained and not approved by the DRIRE as recreational vehicles are not accepted.

Article 2

The area includes parking spots and a service station for water supply and wastewater disposal. Each pitch may host up to 6 people.

Article 3

Rates are set by Camping-Car Park and the local authority. Tourist tax is applied according to current regulations. Two pricing tiers: up to 5 hours (with all services), and beyond 5 hours (24-hour rate).

USAGE RULES

Article 4

A personal account on the CAMPING-CAR PARK app is mandatory to access the area. Access is granted via a card or unique code. Account top-ups via app, website, or customer service.

Campers without vehicles must contact Customer Service if staying more than 3 days.
Article 5
Stays over 3 days require prior reservation.
Article 6
Pets are allowed, kept on a leash, and owners must clean up after them.
Article 7
Wood/charcoal barbecues and open fires are prohibited. Gas stoves allowed with restrictions. In case of fire,
call 112 or 18.
Article 8
No gatherings between 10 PM and 9 AM. Respect for noise and cleanliness required.
Article 9
In case of barrier malfunction, contact CAMPING-CAR PARK at +33 1 83 64 69 21 (non-premium call).
LIABILITY
Article 10
Guests are responsible for keeping their pitch clean and must dispose of waste in designated bins.
Wastewater disposal on pitches is prohibited.
Article 11
Only one pitch and one electric outlet per vehicle.
Article 12
Driving/parking at own risk. No surveillance contract. Guests liable for any damage caused.
Article 13
Accounts must be credited before entry. Misuse of access system results in 300 fine.
Article 14
The area may be closed temporarily for maintenance or safety reasons.
Article 15

Guests must check ground before parking. Recovery costs are the guest's responsibility.

Article 16

Checks may be conducted by authorities. Offenses (e.g., theft, unauthorized access) will be prosecuted.

Theft punishable by 3 years in prison and 45,000 fine.

APPENDIX - Vehicle Regulations

Double-axle motorhomes are allowed if within legal weight limits.

Double-axle caravans and Class 3 vehicles (e.g., trucks, coaches) are prohibited.
